Various initiatives are set in place to enrich the curriculum besides the curriculum delivery methods to create a niche space for the University.

IQAC has taken initiatives towards enrichment of teaching learning process through effective implementation of OBE, review of teaching learning material, revision of curriculum, assessment of PO / CO, monitoring mentoring modules on ERP and conducted regular Quality awareness programmes

(FDP/SDP/ Symposium / workshop) on quality initiatives. IQAC channelizes all statutory and apex bodies' approvals, It is evident from the analysis that there has been a sustained improvement in national and international ratings/rankings/ recognitions and prepares annual reports on Quality
